Personal information

Purpose of Data Processing and Legal Basis for Processing

Data Recipients

Your personal data may be shared with the marketing agency collaborating on the event organization. Your data will not be transferred outside the European Economic Area (EEA).

Data Retention Period

Your personal data will be stored until you withdraw your consent or until they are no longer necessary for the purposes for which they were collected.

User Rights

In accordance with the GDPR, you have the following rights regarding your personal data:

- Right of access: To request access to your personal data.
- Right to rectification: To correct inaccurate or incomplete data.
- Right to erasure ("right to be forgotten"): To request the deletion of your personal data.
- Right to restriction of processing: To limit the processing of your data under certain conditions.
- Right to data portability: To receive your data in a structured, commonly used format and transmit it to another controller.
- Right to object: To object to the processing of your data in certain situations.
- Right to withdraw consent: At any time without affecting the lawfulness of processing based on consent before its withdrawal.
